Participant

I hereby make application to enter the Cowley County 4-H Catch-A-Calf Contest.

I understand that exhibitors must be at least 10 years of age before January 1 of the current 4-H year. Exhibitors should not have reached 19 before January 1 of the current year to be eligible to participate.

Participants must have a finalized 4-H enrollment by the set Catch-a-Calf event on October 11, 2025.

I understand that this is a huge learning and leadership opportunity. If I am chosen for the Catch A Calf program. A key component of this program is not only successfully raise a market steer, attend clinics, workshops and tours, but also have initiative and drive to seek further knowledge, research and training on their own, utilize mentors and work together with current/past CAC applicants.

I understand that if I am awarded to be a participant, calf must be picked up from the Catch-a-Calf event held at the end of October and started immediately as a 4-H project for exhibit at the August 2025 Cowley County Fair.

If I should receive a calf, I will be responsible for feeding, handling, and caring for the calf next year. It is agreed and understood that the responsibility for the calf and its actions shall rest with the 4-H Catch-A-Calf winners.

The calf must be tagged at the scheduled Beef weigh and tagging in March and exhibited in the market beef class. We would like for the Catch a Calf to be sold in the premium sale but if youth have another Market Animal that would receive a higher lot number in the sale they may sell that animal. However, the Catch a Calf is still Terminal and must be in the Carcass contest. It is the exhibitor's responsibility to private treaty, market and sell the meat. Processing should be completed at Walnut Valley or Burden Meats unless further instructed. With carcass evaluations to follow fair. Special Prizes will be awarded to Catch a Calf exhibitors. Once a participant has won Champion or Reserve Champion in the Catch a Calf program, exhibitor will be ineligible to apply the for the program in the future.

I understand if the calf is NOT shown in the 2026 Cowley County Fair Market show, due to health issues exhibitor is expected to pay back 35% of purchase price and 50% if the calf is NOT shown due to lack of proper management in feeding and preparing the calf to show. This is to be determined by the Catch a Calf committee on case by case instances. If Calf is to die it is the youths responsibility to have a necropsy preformed. For ANY instance of health, wellbeing or concern contact Sarah immediately to update.

All premium money won will belong to the member. When the calf is sold, the check for payment will be sent after a final thank-you letter is sent to the sponsor *and* a copy is received by the Cowley County Extension Office.

Exhibitors will be expected to send a total of 5 sponsor report letters along with a **copy** of this letter sent to the Cowley County Extension Office. Letters must be postmarked or emailed by the last day of the scheduled month. Failure to write the required letters may result in forfeiture of the calf. Each member must complete a detailed 4-H record book for the calf, including a story, pictures, sponsor letters and activities list for the entire project. A complete record must be kept and will be exhibited at the 2026 Cowley County Fair. The book may be picked up late Monday night after the premium sale before clean up.

The Catch-a-Calf Committee reserves the right to remove a calf from any member who does not abide by the Catch-a-Calf Rules and Regulations including but not limited to the failure to write, send, and submit a copy of the scheduled sponsor letters, failure to maintain accurate records, failure to provide adequate care and/or feed to the calf, or failure to take full responsibility for the welfare of the calf. If any calf is removed, no allowances will be made for any expenses incurred.

Interview

Will be youth talking to the judge in the Catch A Calf Showcase at the Cowley County Fair. The judge will come to each participant and talk to them. This is the opportunity for the participant to speak loudly, confident and clearly to the judge. Telling them all about this program, how it helped them and all the opportunities it has led to. The judge does not know about this program...tell them all! They will be looking for the youth that did the most with this opportunity.

Showmanship

This will take place in the Catch A Calf Showcase at the Cowley County Fair. The judge will be judging the youth on their showmanship skills and award points accordingly.

Sponsor Letters

Sponsorship letters will be in the Catch A Calf record books. Each letter is worth 20 points. Make sure to have good, meaningful content in your letters. Points scored by the House Committee.

Average Daily Gain

The average daily gain will be out of about 30 points. Average Daily Gain for the Catch A Calf Showcase will be figured from the weight you received your calf at the House Appreciation Dinner to your check in weight at the County Fair. Average Daily Gain (ADG)=Ending weight-Beginning weight/days. If your ADG is 3.25 your CAC Points will be 33.

Live Placing

The judge will assign points at the Catch A Calf Showcase on how he placed the animals.
