Dear 4-H Families;

Thank you for your patience. The last several months have been filled with uncertainty. We appreciate your grace as we figure out how to navigate these times and work to continue to provide you Extension programming. We know you have eagerly been awaiting an update and news about the 2020 Cowley County Fair. As of June 1, 2020, the Cowley County Fair Association voted to table a decision regarding the fair until its June 15 meeting.

These are directives from K-State Research and Extension state administrators regarding Extension responsibilities:

1. K-State Research and Extension is committed to the health and wellbeing of the public and the participants in our Extension programs.
2. K-State Research and Extension has no authority over county fairs.
3. K-State Research and Extension only has authority over the 4-H and other extension programs/activities that are showcased at county fairs.
4. K-State Research and Extension should plan for a traditional face-to-face and non-face-to-face alternative.

Our number one priority is that Cowley County 4-H'ers have the opportunity to showcase their 4-H projects and receive feedback from judges. With that, we have been exploring various options and those are included in this issue of the Flash. We are also working with the fair board to explore opportunities for a virtual livestock sale.

Because of concerns for the health and safety of all participants, families and the public, we are in a "wait and see" mode regarding the 4-H food stand and Barn 4 schedule. We ask for your continued patience in the release of that information for your club sign up.

Regardless of how it takes place, this year's fair is going to look different. We know that we can count on the strength and support of our 4-H families as we provide a positive learning experience for 4-H youth. Let's continue to "Make the best better!"

Kansas 4-H has provided statewide guidance for exploring options for fair showcase experiences. Based on our program size and facility, the next pages describe options. Due to the nature of community health, these options provide us with a mechanism to allow 4-H'ers to showcase their exhibits.

Barn 4 exhibits, Dog, Rabbits, Pigeons & Poultry

Primary Plan:

- Entirely Virtual for 4-H static exhibits, dogs, rabbits, pigeons & poultry
- Use FlipGrid system to submit videos of each project entry.
- Judge will respond with recorded video and/or written comments via Flipgrid. Only exhibitor, superintendent, and Extension staff will have access to their feedback.
- Champions and special awards will be awarded. Projects might be featured on social media.
- Pre-entries due by July 1. FlipGrid submissions due by 9 a.m. Monday, July 27. Potential limit to number of virtual exhibits per project area.

Additional option if Cowley County is in Ad Astra Phase 3:

- Food projects to offer “drop and go” judging experience on Tuesday, July 28 (FlipGrid submission still expected by July 27) at 4-H Food Stand. A one-way drive thru will be designated for exhibit drop off.
- Access inside food judging area restricted to judges and volunteers.
- Volunteers are encouraged to wear cloth face coverings. Face coverings will be available for those without masks.
- Handwashing and hand sanitizing stations will be available and promoted during judging.
- Bathrooms and door handles will be disinfected every hour during the judging process.
- Signs will be posted to encourage COVID-19 healthy precautions.
- Building will have markers on the floor to assist with social distancing during the check-in and judging process.
- Food items (excluding food gift baskets and food preservation) will be distributed to community partners OR available to claim at end of judging.

Face to Face Option (if in Ad Astra Phase Out and adequate number of judges are available):

- Projects might not be on public display.
- Conference judging will take place on Tuesday, July 28 (proposed time 3-8 p.m.)
- Volunteers, participants and judges will practice proper social distancing and steps above will be followed for healthy precautions.
- Virtual entry is available for exhibitors upon request (due by July 15.)

4-H/FFA Livestock and Horse

Primary Plan (Ad Astra Phase 3 or Phase Out)

- 4-H/FFA division only.
- Show and go livestock showcase experience. Livestock will arrive the morning of their scheduled show date, weigh-in, show, and then be dismissed that same day. No livestock will stay overnight.
- Exhibitors will show out of trailer (no pens will be set up except for show and staging areas).
- All exhibitors and spectators are encouraged to wear cloth face coverings. Face coverings will be available for those without.
- Handwashing and hand sanitizing stations located throughout the fairgrounds.
- Signs will be posted to encourage COVID-19 healthy precautions.
- Social Distance between family units and exhibitors strongly encouraged.
- Exhibitor and immediate family only on grounds. A limit on immediate family allowed with each exhibitor may be implemented to follow crowd capacity rules.
- Immediate family to only be in the show area when their exhibitor is in the show ring or holding area.
- Smaller number of showman in each class to maintain social distance inside the show ring.
- Cattle, sheep, goats, equine will be set up 6ft apart while in the ring. Swine classes will be broken into smaller classes to ensure distance can be obtained.
- No Round Robin.
- Livestock auction will be hosted virtually through an online platform. Each exhibitor can sell one market project. Project chosen for auction will be submitted prior to fair and bidding will take place at a time and date designated by the Sale Committee.
- Sale committee is seeking base bid options for extra nominated animals.

Backup Plan (Ad Astra Phase 2)

- Entirely Virtual for all livestock and horse.
- Use FlipGrid system to submit videos of each project entry.
- Judge will respond with recorded video and/or written comments via Flipgrid. Only exhibitor, superintendent, and Extension staff will have access to their feedback.
- Champions and special awards will be awarded.
- Pre-entries due by July 1. FlipGrid submissions due by 9 a.m. Monday, July 27. Potential limit to number of virtual exhibits per project area.

4-H Campference

While we are sad we will not be at Rock Springs for 4-H Campference this year, we will have an opportunity to be together digitally/virtually for an experience on June 23-24, 2020.

Tuesday, June 23 sessions:

It will include some of our favorites in a new way, like a talent show, a campfire, camp groups and a camp craft. Delegates will also take part in a 4-H Community Conversation and participate in a skill building workshop.

Campference is for Ages 12-14, before January 1, 2020. Registration will close June 12, 2020.

Participation will require an internet connection and a device (computer, tablet or phone).

There will be no cost for the program in 2020-21 since the five varieties are again being sponsored by commercial companies. It is very important that we know the number of participants early, so we can have enough seed and metal signs available for Extension agents and leaders to pick up at the Kansas State Fair. New participants will receive a free large plot sign, and five free individual variety signs. These are scheduled to be distributed on Friday, September 11th at the 2020 Kansas State Fair.

Don't forget to pull your wheat samples for your county fair, that may be eligible for the Kansas State Fair 4-H Crops Division. Livestock Ownership Requirements

In order to exhibit livestock at the Cowley County Fair, members must meet the following ownership/leasing deadlines.

Market Steers/Market Heifers: Must be owned by March 3, 2020 and tagged with official Cowley County Extension issued tag/weighed at official beef weigh-in.

Breeding Heifers, Gilts, Does and Ewes: Must be owned by the exhibitor by May 1, 2020. Registered females may be co-owned/co-registered by two or more members in the same family. Registration must be in the name(s) of the exhibitor(s) by May 1, 2020.

Commercial females must have a 4-H eartag.

Second Year Bucket Calves: Must be tagged with Bucket Calf tag. Market calves must be tagged by March 3, 2020 at the official weigh-in.

Bucket Calves: Must be born between January 1 and May 31, 2020 and nominated by May 1, 2020.

Swine: Market and Swine must be owned and nominated by May 1, 2020. Market Swine must be born after December 1, 2019.

Market Lambs: Market Lambs must be born after January 1, 2020. Lambs must be owned and nominated by May 1, 2020.

Market Meat Goats: Market Meat Goats must be owned, nominated by May 1, 2020. Market Meat Goats must still have their milk teeth at the fair.

Dairy Cattle: Must be owned or leased by the exhibitor at least 100 days before the fair. All lease, registration and/or transfer papers must be in the name of the exhibitor by June 15, 2020.

Dairy Goats: Registration papers or stamped duplicates must be in the sole name of the exhibitor by May 1 of the current 4-H year if the animal was given to or purchased by the exhibitor. If the animal was born to an animal the exhibitor owned and registered, then ownership would start the day the animal was born and any date of registration up to the show is acceptable as long as registration papers are available at check-in. For those that choose to lease, a doe must be leased by May 1 and a lease form must be turned in by June 1 to the Extension Office showing dates of lease. Registration papers are also required to be shown at check-in for leased registered goats. Grade goats must have a breeding affidavit filled out and turned in to the Extension Office by June 1 as well as provide a copy at check-in.

STATE YOUTH LIVESTOCK nomination deadline for swine, meat goats and sheep is NEAR!

Commercial heifer, market swine, commercial gilts, market lambs, commercial ewes, and all meat goats (market and breeding does) are **due JUNE 15**.

June 15, 2020 is a postmark deadline. Certified mail is suggested. All nominations are sent through campus mail which can add a delay in receipt of your nomination - yet another reason to complete this task early.

PLEASE do not to wait till the last minute to request your animals be tagged or that your nomination forms are signed by an agent. June is a busy month and Kelsey doesn't want to miss helping livestock families properly nominate their livestock.

Important Reminders/Suggestions

- Must use the 2020 nomination forms to be accepted
- The 2020 nomination forms are fillable PDF's AND have a 2nd page that is a checklist - please double check your nomination.
- Ear notches are required for swine nominations.
- Full Scrapie Tag #'s are required for sheep and goats.
- Cost = \$8.00/animal and checks are to be made payable to KJLS.
- There is a \$20 incomplete fee if any information is missing or any part of the nomination has to be returned.

Kansas State Fair Livestock Entries are due to the State Fair July 15. All youth entry forms may be submitted online. However, they must be printed off and signed by authorized agents, parents, and exhibitors before entry form is complete. Entries may be mailed or faxed to: Kansas State Fair, Attn: Competitive Exhibits, 2000 N. Poplar, Hutchinson, KS 67502, Fax # 620-669-3640. Entry information is available at www.kansasstatefair.com. Printable entry instructions are available by clicking on "online" registration process. Printable and electronic entries are available.

Nominating Livestock for the Kansas State Fair and Kansas Junior Livestock Show

In order to be eligible to exhibit livestock (Beef, Sheep, Meat Goats, Swine) in the Grand Drive of the Kansas State Fair and/or the Kansas Junior Livestock Show, exhibitors must complete the state nomination process found at <https://www.asi.k-state.edu/research-andextension/youth-programs/nominated-livestock/> Any youth exhibiting at the Kansas State Fair or Kansas Junior Livestock Show must also complete Youth for the Quality Care of Animals (YQCA) training. While all face-to-face meetings are suspended through July 4th (currently), state nomination deadlines still stand. If you are a Cowley County 4-H'er wishing to nominate livestock projects for the Kansas State Fair and/or Kansas Junior Livestock Show, you will make an appointment with Kelsey (klnordyke@ksu.edu) to have your livestock tagged by state nomination deadlines. YQCA certification can be done online at <http://yqca.org>. Additional face-to-face YQCA training may be held after July 4.

What Can I Exhibit at the Kansas State Fair??

If your 4-H Age is 9 and older, you are eligible to enter a purple-ribbon exhibit from the Cowley County Fair for judging at the Kansas State Fair in the 4-H Division: photos, food items, gift baskets, educational displays, some notebooks, entomology educational display, entomology collection, clothing construction, horticulture, field crops, floriculture, fiber arts, rabbits, energy management, robotics, rocketry, astronomy, geology collection, geology educational display, woodworking, Shooting Sports educational display, wildlife educational display, poultry, demonstration/illustrated talk and forestry notebook.

Two Senior Division Champions may be selected in Fashion Revue Buymanship and Constructed categories to compete at the Kansas State Fair.

Judges will choose six Visual Arts exhibits to be displayed at the Kansas State Fair.

It is the member's responsibility to complete pre-entry by August 12 in order to exhibit at the Kansas State Fair. Pre-entries may be made in the 4-H office at the Cowley County Fair or in the Extension Office following the fair.

No phone entries will be accepted.

KSF Dog Show

The Kansas 4-H Dog Action team has voted to cancel the in-person state fair dog show for 2020. The group is diligently working to create a non-competitive option where youth will have the opportunity to receive input from 4-H Dog Judges. More information on this will come in the near future.

KSF Geology

In light of being unable to host the geology field trip and circumstances related to specimen collection, the 4-H Geology Action team has voted to modify the collection rules for the 2020 Kansas State Fair.

"the current year specimen number rule shall be modified for the 2020 4-H year for geology exhibit state fair classes 5200, 5201, 5202 and 5203, due to these extraordinary circumstances, to read: Five (5) specimens must be collected during the current 4-H year."

The rule change only pertains to the 2020 4-H year. So for example, this year participants need only 5 (new) specimens collected during the current year, which begins the day after last year's state fair. The total number of specimens (15, 30, 45 & 60) per any given exhibit class remains the same. So for a 15 specimen exhibit, for example, the participant needs only 5 specimens from the current year and the remaining 10 could be collected during previous years.

Kansas 4-H Moves Summer Camp Online

Organizers launch month-long campout in June

MANHATTAN, Kan. – Kansas 4-H youth are still going camping this summer, though it may not be the way they have been used to doing it.

Amy Sollock, the southwest regional specialist for Kansas 4-H Youth Development, said the state's largest youth organization will be celebrating the benefits and traditions of camp on social media during the month of June.

"We've been camping at the Rock Springs Ranch (near Junction City) for almost 75 years, and it's one of our very beloved and time-honored programs," Sollock said. "We love going to 4-H camp at Rock Springs and the benefits that our kids get from camping at Rock Springs are tremendous. There's just nothing like it."

In April, K-State Research and Extension announced that it was ceasing all in-person activities in Kansas at least through July 4. "Like everyone, we were pretty bummed that we would not be able to camp this year, but we understand the reasons why. The health and safety of our participants, volunteers and staff comes first."

Sollock said the state's 4-H leaders, like others throughout the organization, got together and developed ways in which they could still celebrate some aspects of 4-H camp and teach the values the experience offers.

"So," she said, "for the entire month of June, we are going to have all kinds of fun content that we're going to push out through social media, including some fun challenges and videos to celebrate what summer camp is all about."

There is no charge or registration needed to follow along on social media, Sollock said, and many of the activities can be done right in 4-H members' backyards. She urged youth to follow [Kansas 4-H on Facebook](#) to be part of the fun, and to share their own experiences by posting on social media with the hashtag, #4HCampLivesOn.

"We are going to have a backyard photography contest, and the state 4-H Youth Council has planned a virtual camp song challenge," she said. "We are hoping it becomes one of those challenges that goes viral and can provide kids with a lot of humor as we sing our silly camp songs."

Sollock said plans are in the works to create videos that will be recorded from popular sites at Rock Springs such as the flagpole, campfire circle, water wheel and Palomino horse herd. "There are some cool things in the works," she said.

Kansas 4-H will offer several outdoor education videos on topics normally taught at camp such as using sunscreen and bug repellants, the importance of drinking water, fishing tips and bike safety. Kansas 4-H will also promote opportunities for service activities in local communities.

"We want to give kids a chance to celebrate what they're missing out on this year," she said. "We know that 4-H camp is a favorite activity for many kids each year."

"We've seen some really creative efforts from kids and families, volunteers across the state as we navigate this situation that none of us have ever lived through before. There's a lot of fun that can be had right in your backyard."

Sollock also made a prediction: "4-H Camp 2021 is going to be stronger than ever and I don't think we'll ever be so excited for a 4-H camping season as we will be next year."

Last year, the Dr. Bob Hines' Kansas Swine Classic attracted 156 exhibitors showing 317 pigs from 45 counties. Currently K-State has a policy that on-campus personnel cannot host large in-person events until July 31. Thus we are not able to host the 2020 event at the Riley County fairgrounds. However, we feel strongly the show must go on and have decided to hold the 2020 Dr. Bob Hines Swine Classic as a virtual event. We are currently finalizing all details for the show, but we do plan to proceed with the show, showmanship, skillathon and photo contest. We have ordered all awards (buckles, banners, clipboards, breed champion and reserve awards, others) that we normally present to youth participants.




